Mr. Jarrett is a member of several practice committees within the American Bar Association's Labor and Employment Section, and serves as a contributing editor to national treatises on the Fair Labor Standards Act and the Family and Medical Leave Act. Mr. Jarrett is an elected member of the Board of Bar Commissioners of the State Bar of New Mexico—the group of attorneys, elected by their peers from throughout the State, who govern the Bar. As a Bar Commissioner, Mr. Jarrett serves on the Personnel Committee, the Continuing Legal Education Advisory Committee, and as liaison to the Board of Bar Examiners.
